Important!

This warranty is NULL and VOID without a signed warranty card in our files!

All warranty periods begin on the date of purchase and a warranty registration must be filled out by your dealer, and signed and dated by both you and your H&H dealer to activate this warranty. No warranty claims can be accepted without this warranty registration on file at H&H Trailer Company.

The following warranty covers all models except cargo and aluminum trailers. Cargo and aluminum trailers carry a separate warranty.

Wood flooring: Limited Lifetime no rot warranty on all wood floors

All H&H trailers with our standard treated wood flooring now receive a direct from the original supplier limited lifetime warranty. All warranty claims for the floor must be submitted directly to CSI, One Woodlawn Green, Suite 250 – 200 East Woodlawn Road, Charlotte, NC 28217. The warranty covers all lumber on our trailers against decay or termite damage that would make the wood structurally unfit for the purpose it was originally intended for. To better understand this warranty, a copy of the written warranty is included elsewhere in this price sheet. This warranty is not handled by H&H, any representative of H&H or any H&H dealer. All warranty claims for lumber must be submitted in writing to CSI at the mailing address above. H&H offers no reimbursements or supplemental warranties on floors in addition to the warranty provided by CSI. Warranty is non-transferable and ends when original owner sells trailer. H&H cannot and will not be held liable for cost to transport units from any location to any other location, loss of use, incidental damage or any other expenses other than the costs to perform the repair itself. This warranty will not be in place for any unit until a signed warranty card is in file at the H&H Trailer offices, 222 N 1st St, Clarinda, Iowa 51632. There will be no exceptions to this rule.

Trailer frame, tongue, and crossmembers: 10 year limited warranty

H&H will warranty these items for ten (10) full years from the date of purchase against any defects in materials or workmanship including weld and steel quality. This warranty excludes steel decking or open pit decking. All warranty claims MUST be inspected and approved by your dealer and all repair procedures must be pre-approved by H&H and its management before any repair work can begin. There are no exceptions to this procedure, so please contact your H&H dealer immediately before attempting any repairs or modifications on your H&H chassis. Our warranty does not cover abuse or neglect/corrosion which includes, but is not limited to improper usage, overloading, accident related damage, improper loading or incorrect weight bias loading of your trailer chassis. As always, contact your H&H dealer if you have any questions. Your H&H dealer MUST personally inspect any and all items before they can be considered for warranty service or reimbursement. Warranty is non-transferable and ends when original owner sells trailer. H&H cannot and will not be held liable for cost to transport units from any location to any other location, loss of use, incidental damage or any other expenses other than the costs to perform the repair itself. This warranty will not be in place for any unit until a signed warranty card is in file at the H&H Trailer offices, 222 N 1st St, Clarinda, Iowa 51632. There will be no exceptions to this rule.

Attached hardware: 90 day warranty

H&H will offer a warranty against defects in materials or workmanship on the following items for a period of 90 days from the date of purchase by the end user. This is limited to the following items. Couplers, safety chains, storage jacks, tilted hinges and related hardware, ramp gates and hardware, ramps and ramp carriers, fenders and fender bracing, stake pockets, d-rings, axles, bearings, seals, brakes and brake related hardware, leaf springs and all suspension components. H&H reserves the right to refuse warranty on any component if, according to our laboratory testing practices such damage is caused by excessive high speeds while towing, overloading, improper or unbalanced loading, improper use, neglect or abuse. All such warranty will be given at the sole discretion of The H&H Trailer Company and its management. As always, contact your H&H dealer if you have any questions. Your H&H dealer MUST personally inspect any and all items before they can be considered for warranty service or reimbursement. Warranty is non-transferable and ends when original owner sells trailer. H&H cannot and will not be held liable for cost to transport units from any location to any other location, loss of use, incidental damage or any other expenses other than the costs to perform the repair itself. Misc. Components warranty: 30 days

Lights and lighting attachment hardware, license brackets and attaching hardware, wiring, wiring connectors, trailer lighting plugs, fender rock guard, warning decals and emblems attached to the trailer. Most items listed here will be warranted less labor but components can be shipped directly to the end user at no cost if such warranty claims are approved.
